About

The Accreditation Review Commission on Education for the Physician Assistant (ARC-PA) is the accrediting agency that protects the interests of the public and the Physician Assistant/Physician Associate (PA) profession by defining the standards for PA education and evaluating PA educational programs within the territorial United States to ensure their compliance with those standards.

The ARC-PA is an independent accrediting body authorized to accredit qualified PA educational programs leading to the professional credential, PA. Accreditation is a process of quality assurance that determines whether the program meets established standards for function, structure and performance. The ARC-PA does not accredit any academic degree awarded by the sponsoring institution of the PA program.

The ARC-PA encourages excellence in PA education through its accreditation process by establishing and maintaining standards of quality for educational programs. It awards accreditation to programs through a peer review process that includes documentation and periodic site visit evaluation to substantiate compliance with the Accreditation Standards for Physician Assistant Education. The accreditation process is designed to encourage sound educational practices and innovation by programs and to stimulate continuous self-study and improvement.

In addition to establishing educational standards and fostering excellence in PA programs, the ARC-PA provides information and guidance to individuals and organizations regarding PA program accreditation.

The ARC-PA is recognized by the Council for Higher Education Accreditation (CHEA). The CHEA scope of recognition is for programs preparing individuals for entry into PA practice located in institutions in the U.S. that are accredited by recognized regional accrediting bodies. The CHEA scope does not cover the accreditation of clinical postgraduate PA programs.

ARC-PA

Geographic Scope

The ARC-PA only accredits qualified PA programs offered by, or located within, institutions chartered by, and physically located within, the United States, and where students are geographically located within the United States for their education. (The United States are defined as "the fifty States, the District of Columbia, the Commonwealth of Puerto Rico, the Commonwealth of the Northern Mariana Islands, Guam, the Virgin Islands, American Samoa, Wake Island, the Midway Islands, Kingman Reef, and Johnston Island." A program may satisfy the requirement of supervised clinical practice experiences through medical facilities located in the United States and through a limited number of medical facilities that are accredited by the United States Joint Commission and operated by the American government under a signed Status of Forces Agreement with the host nation.)

The ARC-PA does not accredit educational programs leading to the PA credential in institutions that are chartered outside the United States or programs provided in foreign countries by ARC-PA accredited U.S. PA programs.

Data Collection and Methodology

Introduction

ARC-PA has consistently collected data on PA programs that have applied and wish to continue with being accredited as part of the necessary steps for programs to obtain and maintain accreditation. In 2021, ARC-PA took steps to enhance data analysis and reporting efforts in response to the need for more transparency and increased communication between ARC-PA and the programs it accredits. This report extends this goal with data compiled from 2023. The data is gathered through data input into the secure portal within ARC-PA's website, from required site visits for accreditation purposes, and reviews completed at commission meetings.

Data Analysis


The information reflected in this report includes aggregated data collected from the required annual submission of program information from accredited PA programs and ARC-PA commission meetings. Entry Level Program commission meetings occurred in March, June, and September of 2023. Post-Graduate commission meetings occurred in February, June, and September of 2023. Eligible programs were required to submit their annual report by 15 December 2023 (n=302). Entry Level Programs that were awarded provisional accreditation in the June and September commission meetings are not required to submit a report (at that date) and thus are not included in the aggregate analysis. Post-graduate programs awarded provisional accreditation have not been required to submit an annual report, thus the data presented is limited to information ascertained from the Post-Graduate commission meetings and reported data in the Portal.

The data was examined for consistency, potential errors, and in certain cases, absence of data. Some information requested is not required to be shared or applicable to certain programs. Therefore, for programs with obvious error, inconclusive data, or lack of a data point, the data was not included in the final analysis, and the number of programs in each data set may vary.








Closed Programs Over Time







Matriculation Date










Max Number of Students/Program








Aggregate Number of Students/Program





Semester Hour Credits







Program Length












Clinical Program Length





Total Program Length









% Simulated Patient Encounters























Probation Operations Budget





















% Administrative Staff Attrition

















Average Personnel/Program





Average FTE/Program















Cumulative Accredited Programs
























Max Number of Trainees/Cohort




Max Number of Cohorts/Year





Operations Budget












%FTE/Standards Role







Administrative Support Staff	Those individuals providing administrative, secretarial, or clerical help to the program. Administrative support staff do not include other staff working in or with the program who are assigned a traditional faculty role or those who function to provide technical assistance for instructional technology or data analysis/
Attrition	A reduction in number. Student attrition: the permanent loss of a matriculated student from the course of study in a PA program. Faculty attrition: the loss of a faculty member from a position assigned to a PA program
Clinical Education	The component of the PA educational program that provides for supervised, competency-based, clinical education and experience.
Commissioner	Commissioners are elected by the ARC-PA from a slate of nominees submitted by the ARC-PA collaborating organizations. Commissioners initially serve a 3-year term and are eligible for reappointment for a second 3-year term. Commissioners begin their service January 1 and complete their terms December 31 of the years involved. At Large commissioners are elected for a single 3-year term and are not eligible for re-election.
Continued	Accreditation-Continued: Accreditation status granted 1) when a currently accredited program follows the Standards, 2) in the case of a program holding Accreditation-Probation when the program has demonstrated that it is once again in compliance with the Standards, or 3) when a program holding Accreditation-Provisional demonstrates compliance with the Standards after completion of the provisional review process. Accreditation-continued status remains in effect until the program closes or withdraws from the accreditation process or until accreditation is withdrawn for failure to comply with the Standards.
Didactic Education	The component of the PA educational program that provides formal instruction with specific objectives and methods for assessing the student's progress from entry-level competency.
Distance Education	Distance education is using technology (e.g., internet, audio/video conferencing, pre-recorded materials) to deliver instruction to students who are separated from the instructor, either synchronously or asynchronously.
Distant Campus	A campus geographically separate from the main program at with didactic, preclinical, or clinical instruction occurs for all or some of the students matriculated to that campus.
Elective Rotation	Supervised clinical practice experiences that may differ by student, and which allow students to gain exposure to or deeper understanding of medical specialties related to their clinical or academic areas of interest.

Term	Definition
Entry Level Program	Entry Level accreditation is provided to programs designed to train PA students in acquiring the knowledge and skills needed to enter the PA profession. Entry level PA programs are located within a recognized regionally accredited post-secondary institution authorized to confer upon graduates of the PA program a graduate degree.
Expedited Review	To provide timely review and streamline the workload of the commission, certain documents that need commission review may be processed through Expedited Review. Those documents include Program Progress report, Report due as defined by the ARC-PA, and Program Change as defined by the Standards.
Final Provisional Visit	Conducted 18-24 months following the second provisional review by the commission. This visit verifies the institutions and program's demonstration of compliance with the Standards including their ability to incorporate and report the findings of a robust self-assessment process as required by the ARC-PA.
Focused Visit	May be conducted at any time to evaluate a specific Standards related problem(s) identified by a site visit team, the ARC-PA, or in response to a concern received by the ARC-PA. Details about requirements for the focused visit are conveyed to the program in writing prior to the visit. Focused visits usually are conducted by specialist visitor(s), who must include commissioner(s) of the ARC-PA or ARC-PA staff.
Informational Item	Documents provided by a program that is purely informational in content.
Initial Provisional Visit	Conducted to a new developing program that is within six to 12 months of matriculation of students. This visit verifies an institution's ability to begin a program in compliance with the Standards, and the program's readiness to matriculate students.
Instructional Faculty	Individuals providing instruction or supervision during the didactic and/or clinical phases of the program, regardless of length of time of instruction, faculty status, or rank.
Medical Director	Physician assigned to the PA program an who reports to the program director. Supports the program in ensuring that didactic and clinical instruction meet current practice standards as they relate to the role of the PA in providing patient care.
NCCPA	National Commission on the Certification of Physician Assistants.
No Standards Role	Individuals working at a PA program whose role is not defined by ARC-PA standards.
PANCE	Physician Assistant National Certification Exam administered by NCCPA.

Term	Definition
Physician Assistant/Physician Associate	Licensed medical professional that is academically and clinically prepared to provide health care services as a member of collaborative health care teams. PAs make clinical decisions and provide a broad range of diagnostic, therapeutic, preventive, and health maintenance services. The clinical role of PAs includes primary and specialty care in medical and surgical practice settings. PA practice is centered on patient care and may include educational, research, and administrative activities.
Post-Graduate Program	Accreditation-Clinical Postgraduate Program is the status of accreditation granted when a new or currently accredited clinical postgraduate program is in compliance with the Standards for Clinical Postgraduate Programs. Accreditation-clinical postgraduate program remains in effect until the program closes or withdraws from the accreditation process or until accreditation is withdrawn for failure to comply with the Standards, ARC-PA requirements or procedures.
Post-Graduate Provisional	If the program is awarded Provisional Accreditation, the program will be scheduled for a more thorough review and determination of Continued Accreditation status. This subsequent review will include an additional application, self-study report and site visit. The information obtained through this process will be reviewed by the subcommission and an accreditation determination will be made.
Preceptor	Entry Level: Any instructional faculty member who provides student supervision during supervised clinical practice experiences. Post-Graduate: A licensed and appropriately credentialed physician (MD or DO) or other licensed medical professional serving to supervise the patient care activities of the PA trainee, which can include didactic and clinical instruction.
Principal Faculty	Those faculty working at least 50% FTE with primary academic responsibility assigned to the PA program who report to the program director.
Probation	Accreditation-Probation is a temporary accreditation status initially of not less than two years. However, that period may be extended by the ARC-PA for up to an additional two years if the ARCPA finds that the program is making substantial progress toward meeting all applicable Standards but requires additional time to come into full compliance. Probation accreditation status is granted, at the sole discretion of the ARC-PA, when a program holding an accreditation status of Accreditation – Provisional or Accreditation – Continued does not, in the judgment of the ARC-PA, meet the Standards or when the capability of the program to provide an acceptable educational experience for its students is threatened. Once placed on probation, a program that fails to comply with accreditation requirements in a timely manner, as specified by the ARC-PA, may be scheduled for a focused site visit and is subject to having its accreditation withdrawn.



Term	Definition
Probation Visits	Conducted near the end of a period of probation to programs with an accreditation status of Accreditation-Probation. Details about requirements for these visits are conveyed to the program in writing prior to the visit. Probation visits usually are conducted by specialist visitor(s), who may include commissioner(s) of the ARC-PA or ARC-PA staff.
Program Director	A Physician Assistant responsible for the program, and for the timely and accurate completion of all required elements
Program Report	Documents required to be provided by a program that require a full review by the commission.
Provisional	Accreditation – Provisional is an accreditation status granted when the plans and resource allocation, if fully implemented as planned, of a proposed program that has not yet enrolled students appear to demonstrate the program's ability to meet the ARC-PA Standards or when a program holding accreditation-provisional status appears to demonstrate continued progress in complying with the Standards as it prepares for the graduation of the first class (cohort) of students. Accreditation – Provisional does not ensure any subsequent accreditation status. Accreditation – Provisional is limited to no more than five years from matriculation of the first class. Accreditation-provisional remains in effect until the program achieves accreditation-continued after its third review, closes or withdraws from the accreditation process, or until accreditation is withdrawn for failure to comply with the Standards.
Provisional Monitoring Visit	Conducted within six months of graduation of the first cohort of students. This visit verifies the sponsoring institutions and provisionally accredited program's progress in delivering the program in compliance with the Standards and their ability to continue to do so.
Provisional+Probation	Programs that have a combined accreditation status of Accreditation- Provisional AND are on Accreditation-Probation
Site Visit	The purpose of the site visit is to verify, validate, and clarify, if necessary, the information supplied by the program in its application materials as evidence of its compliance with the Standards. The visit focuses on the program self study and how the program's self-identified concerns and problems are being addressed in relation to the Standards. A site visit team can conduct a thorough and accurate assessment of the proposed educational program for physician assistants within two days or less. Site visits should provide the site visit team members information on the planning and progress of the program and should provide the team the opportunity to meet and discuss the program with its administration, faculty, staff and preceptors.
Supervised Clinical Practice Experiences (SCPE)	Supervised student encounters with patients that include comprehensive patient assessment and involvement in patient care decision making and which result in a detailed plan for patient management.

Term	Definition
Telemedicine/Telehealth	The use of electronic information and telecommunications technologies to support long-distance clinical health care, professional health-related education, public health, and health administration.
Total Budget	Include major sources of financial support AND expenditures for the Entire Program
Trainee Clinical Experience	Supervised clinical practice experiences involving direct patient care provided by a PA trainee. At the discretion of the program or sponsoring institution, this term may be recognized as rotations or clerkships.
Withdrawn/Withheld	Accreditation Withheld is a status granted when a PA program, seeking accreditation-provisional, or a clinical postgraduate PA program seeking accreditation-clinical postgraduate program, is not in compliance with the Standards. The program receiving this accreditation status may voluntarily withdraw from the accreditation process within the 30-day appeal timeframe. Accreditation Withdrawn is a status granted when an established program is determined no longer to be in compliance with the Standards and is no longer capable of providing an acceptable educational experience for its students, or when the program has failed to comply with ARC-PA accreditation requirements, actions or procedures. The program may voluntarily withdraw from the accreditation process within the 30-day appeal timeframe.
